Re: Proposed Development – 37 Townhill Road, Dunfermline

I have been contacted by a few of my constituents highlighting their concerns regarding the proposal to demolish the existing building and build flats in five three-storey blocks at the above location.

They have explained that they have concerns about the height of the proposed development and feel that a three storey development is out of proportion with the surrounding area. They are also very concerned that it will greatly reduce the privacy to the neighbouring properties.

They also tell me that they are concerned about the increase in noise, dirt, and the movement of heavy vehicles in this quiet area and feel that the granting of this proposal in its current form would be aesthetically out of place as most of the neighbouring properties are stone built dwellings approximately one hundred years old with slate roofs.

Please could you let me know the current status of the application and confirm that the residents' objections will be considered by the Planning Committee.
